



Our families sometimes don't have the resources to replace clothing that is too small, worn out, or lost because of fire or homelessness. Being able to provide uniform clothing when a child needs it helps to relieve their stress and increases their self-esteem. The clothes closet also helps decrease the stress our staff feels, because we can help their students and they don't have to purchase the items for their students. I wish you all could see the happiness these items bring to our students. Thank you for making a difference!"



VOTE NO ON PROP A

NCJW hosted a special Lunch and Learn on July 19th to discuss why Prop A would be bad for Missourians. State Senator Jake Hummel spoke to the effects Prop A would have on workers' rights and pay if it passes.

He said, "We've got to turn out in August because so much is on the line for Missouri's working people. Prop A could cost thousands of dollars each year for working families. It doesn't just hurt union members, it's an attack on our entire state."

NCJW STL HUMAN TRAFFICKING COMMI

Members of NCJW STL Committee to Combat Human Trafficking met with St. Louis County Executive Steve Stenger to discuss trafficking in our region. The County Executive agrees, "Human trafficking is a crime against the whole of our society and our own St. Louis community. We must continue to join forces to work together to free its victims and to eradicate this crime."

Several action steps to combat human trafficking in St. Louis County were identified. NCJW STL is currently working with the County Executive's office to place a poster in the county offices at the Crossings at Northwest Plaza that will help educate the community about human trafficking as well as provide information for victims to get help.

NCJW STL LEGISLATIVE RECAP

It's been quite a year for NCJW STL in the Missouri legislative session

In our A-List ad at the beginning of session we laid out three legislative priorities:

- 1 Pass legislation to help combat human trafficking
- 2 Ensure that our court system is fair and balanced
- 3 Save the state of Missouri money and help women have the opportunity to reach financial success by making access easier to long acting reversible contraception



We're happy to say that we made significant progress on all three priorities! We've worked for three years on legislation that requires the posting of the national trafficking hotline number in various establishments including truck stops, train stations, strip clubs, and other places where victims may see the posters. It was the first bill passed this year and was signed by the Governor. HB 1246 will take effect in January of 2019.

Raising the age to marry is also critical to combatting trafficking in Missouri. At the beginning of the legislative session, Missouri had the lowest marriage age of the 48 contiguous states. The legislation raises the age that two people can marry to 17. HB 1630 takes effect August 28th. Congratulations to Marilen Pitler and Dianna Fine for their work that helped ensure this legislation passed this year. The bill was signed into law by the Governor on July 13, 2018.

Working with coalition partners, NCJW opposed a bill to modify the way our judges are chosen. That bill did not pass out of committee.

Lastly, our bill to support Long Acting Reversible Contraception (LARC) for MO Health Net patients was passed. Thanks to the leadership of Marlene Hammerman and her LARC advocates working this throughout session, HB1499, the abandoned units bill, passed as an amendment to SB826. It faced almost no opposition in the House or Senate; passing out of the House 133-10 and out of a Senate committee 5-0. With time running out for a full vote of the Senate, it was a strategic move to add the language to several bills that were relevant. The House and Senate reconciliation committees left the language of HB1499 in SB826, so it is officially a done deal.

This bill allows 1,100 MO women to have the ability to have same-day insertion of LARC devices who otherwise wouldn't. Previously, LARC devices that were not claimed after being ordered for MO Health Net patients were destroyed. This was a waste of \$250,000 annually.

Thank you to everyone who joined us in Jefferson City this year to work to improve the lives of women, children and families in Missouri. A special thank you to Steve Jackson who donated his time as a lobbyist to ensure we had the most up to date information on these issues as well as the most effective strategy.

NCJW continues to be a growing force in the Capitol. We have significantly increased the amount of time we are in Jefferson City meeting with legislators, testifying on legislation and providing awareness about our issues. NCJW volunteers and staff went to Jefferson City almost every other week during session and this presence is what helped create our success this year.



NCJW LEADERSHIP RETREAT

On June 1-3, over 200 NCJW women from around the country came to St. Louis to Learn, Connect and Do

This leadership retreat takes place every three years and we were honored to host in St. Louis. Not only did we have almost 30 women attend from our Section, but we had the opportunity to showcase our work and our people. A special thanks goes out to all the women from the St. Louis Section who volunteered at the event and helped us prepare for it.

We spent our time on four tracks of training: Personal Leadership, Outreach and Engagement, Leading for Change and Our Work.

Local presenters included NCJW St. Louis Board members Melissa Alper, Susan Katzman, Darien Arnstein, Dianna Fine and Carly Sparks, along with Marci Mayer Eisen from Jewish Federation and Ruth Lederman from the Boys and Girls Clubs of St. Louis. This cadre spoke about basics like running meetings, personal care for advocates, social media, volunteer outreach, trafficking, governance and raising money through grants and sponsorships. In addition, Adrienne Davis, Vice Provost at Washington University Law School, opened with our keynote program about Women in Leadership and Saturday night featured Mother2Mother: a conversation with black mothers to white mothers about raising our children, sponsored by The Ethics Project.

All attendees were given a little taste of St. Louis in their meeting bags that included a chocolate arch, makeup bags courtesy of Marmi/Wolff Shoes, chocolate bars courtesy of Bissinger's, and eye glass wipes courtesy of VITAS. And, since we couldn't give them provel cheese and toasted ravioli, we opted for a traditional St. Louis treat—mini gooey butter cakes. Everyone learned new skills, connected with leaders from around the country and went back home with a long list of "to do" items in their communities. Learn. Connect. Do. It's who we are and what we do that makes a difference; and coming together to share makes us even stronger.

Rev. Blackmon is the Executive Minister of Justice & Local Church Ministries for The United Church of Christ and Senior Pastor of Christ the King United Church of Christ in Florissant, MO. As a featured voice on many regional, national and international platforms, Rev. Blackmon's life work focuses on communal resistance to systematic injustice. Her response in Ferguson to the killing of Michael Brown resulted in national and international recognition, gaining her many audiences spanning the breadth of the White House to the Carter Center to the Vatican. Rev. Blackmon is a recipient of the NAACP Rosa Parks Award, The Urban League of St. Louis Women in Leadership Award; the National Planned Parenthood Faith Leader Award and was listed in Ebony Magazines 2015 Power 100. Rev. Blackmon was named 2017 Citizen of the Year by the St. Louis American and as one of St. Louis' 100 most influential voices.



Rabbi Andrea Goldstein has been a rabbi at Congregation Shaare Emeth, the largest Reform synagogue in St. Louis, for the past 20 years. Rabbi Goldstein currently serves on the Union of Reform Judaism's Commission on Social Action and the Central Conference of American Rabbis' Justice Team. She is a board member of Nishma and Metropolitan Congregations United and serves on the NCJW Advisory Council as well as the Advisory Committee of the Robert P. Jacob's Jewish Fund for Human Needs. Rabbi Goldstein is a graduate of the Institute for Jewish Spirituality's Rabbinic Leadership Program and the Jewish Mindfulness Meditation Teachers' Training Program and is the founder and director of the Jewish Mindfulness Center of St. Louis. Her rabbinate is centered around the call for social justice and the cultivation of spiritual practices.
