

LOOKING TO THE FUTURE THROUGH THE LENS OF THE PAST

We have some major things going on at NCJW STL! Looking to the future, we are working on our next three-year Strategic Plan and are busy testifying on bills that will make a difference in the lives of women, children and families. The lens of the past will be reflected in our 125th anniversary celebration in 2020. I would like to elaborate on all three.

All forward thinking organizations operate from a strategic plan. We are no different. As we come to a close of the 2016-19 Strategic Plan, our Vice-Presidents and staff are busy meeting with their committees to assess what has been accomplished, what work should continue and what new plans should be made. We recently learned that there are over 1,600 non-profit organizations in St. Louis. Many have either been merging or closing their doors. There is a tremendous competition for dollars from individuals, funders and foundations. How an organization can articulate its mission and goals, measure its success and manage its money is critical. Much of our strength is based on what has been done in previous years. This plan will shape our direction through 2022. If you have any ideas you would like to see incorporated, please email me at susan314@charter.net or call 314.725.8041.

Advocacy has never been more critical. We testified on six bills in the first eight days of March, requiring four trips to Jefferson City. We've met with legislators on unpaid leave for victims of domestic violence, really bad abortion restrictions, voter photo ID funding, immigration status checks by law enforcement, child home day care limits and an allowance for domestic violence survivors to break a lease for safety reasons without penalty. Some of these bills will move out of committee to the floor of the house or senate and when they do, we will be back in Jefferson City. Thanks to our SPA Dianna Fine and Vice-President of Advocacy Nancy Litz for testifying and Linda Dahl, Barb Kramer, Laura Paperner, Mary Murphy, Marilen Pitler, Louise Levine, Heather Silverman and Ellen Alper for joining us on these trips.

The year 2020 will mark our 125th anniversary. We have so much to celebrate, so much to be proud of. Five women will lead our anniversary efforts: Nanci Bobrow, Darien Arnstein, Marilyn Ratkin, Marlene Hammerman and Lisa Gubernik. We are working on a commemorative video, several unique programs and speakers, a family community day of service with many of our current and former partners, fundraising opportunities, a planned giving initiative and so much more. We welcome anyone who would like to volunteer to be part of the overall planning committee or who would like to join us to plan one of the events. Adrienne Davis is the William M. Van Cleve Professor of Law and Vice Provost at Washington University in St. Louis. Her academic teaching and research focus on what she calls "the law of daily life," including property, contracts and trusts/estates.

As Vice Provost, she works for the University's chief academic officer on a suite of initiatives to support faculty hiring, retention/development and designing infrastructure to support students.

In Fall 2017, Davis was recognized with a Washington University Founders Day Distinguished Faculty Award. In the same year, she was also honored as a St. Louis Woman of Achievement for Arts Advocacy. Davis earned her B.A. and J.D. from Yale University where she served on the Executive Committee of the Yale Law Journal.




