
WINE & WISDOM VIRTUAL BOOK CLUB

Come learn and socialize with other NCJWSTL members as we explore fiction and non-fiction books that delve into social justice topics.



Our next book is Ijeoma Oluo's "So You Want to Talk About Race." In this breakout book, Ijeoma Oluo explores the complex reality of today's racial landscape - from white privilege and police brutality to systemic discrimination. It offers straightforward clarity that readers need to continue contributing to the dismantling of the racial divide. Oluo offers a contemporary, accessible take on the racial landscape in America, addressing head-on issues such as privilege, police brutality, intersectionality, micro-aggressions, the Black Lives Matter movement, and the "N" word. Perfectly positioned to bridge the gap between people of color and white Americans struggling with race complexities, Oluo answers the questions readers don't dare ask and explains the concepts that continue to elude everyday Americans.

Oluo is an exceptional writer with a rare ability to be straightforward, funny, and effective in her coverage of sensitive, hyper-charged issues in America. Her messages are passionate but finely tuned, and crystalize ideas that would otherwise be vague by empowering them with aha-moment clarity.



We have also partnered with We Stories to read "Let's Talk About Race," by Julius Lester, a children's book illustrated by Karen Barbour. Julius Lester says, "I write because our lives are stories. If enough of those stories are told, then perhaps we will begin to see that our lives are the same story. The differences are merely in the details." Now Mr. Lester shares his own story as he explores what makes each of us special. Karen Barbour's dramatic, vibrant paintings speak to the heart of Lester's unique vision, truly a celebration of all of us.

CULTURAL INTELLIGENCE – MAKES US ALL BETTER!

To be our best selves in an increasingly multi-cultural world – both individually and as an organization - the ability to create positive relationships across "dotted lines of difference" is essential. Racial identity is in the forefront of American life today and NCJWSTL members also encounter a range of additional identities:

- · Age, educational level, financial status
- Gender, gender identity, sexual orientation
- Career, homemaker, retiree
- Political affiliation and degree of engagement
- Branches of Judaism, synagogue affiliation, Christian, Muslim, and more
- · Citizenship, immigration status, country of origin
- And so many more

Dr. Amy Narishkin uses the term "cultural intelligence" to describe the skill of working comfortably, graciously, and effectively across all these supposed dividing lines. She recently conducted a four-session virtual training to help 45 NCJW leaders refine their skills in that area.

That skill development begins with acknowledging that differences exist and can be a positive addition to our lives. Dr. Narishkin uses the STOP formula as a guideline for behaving in any situation where differences can cause an initial sense of discomfort:



- S Slow down before talking or taking action
- ${f T}-{f T}$ ake three deep breaths to calm and reassure yourself
- ${f O}$ Observe your own reactions, the feelings of the other person, and the safety of the situation
- P- Proceed with an attitude of curiosity and wonder

The acronym is easier to memorize than to put into practice so the workshop participants are meeting monthly in small groups to share their successes and challenges as they elevate their cultural intelligence. Thanks to our group facilitators Amy Hammerman, Susan Dertke Hendin, Julie Hundman, Mary Murphy, Karen Silverman, and Amanda Stein for continuing the work.

Knowing that when we have a child in need, there is a resource so readily available is such a comfort, so that we can spend more time attending to their academic needs."

BACKTOSCHOOL!STORE

After the success of the 2020 NCJWSTL Back to School! Store, the chairs and committee knew there were more needs to be met in our community.

The Back to School! Store donated 1,500 books to the St. Louis Public School Learning Centers. These learning centers were designed for students to have a safe place to engage in virtual learning while their parents or guardians are working. Our donation enabled each child at these centers to have books to read. An additional 150 books were donated to the students at Normandy's Jefferson Elamiddle so that each student can have two new books to take home. We also donated backpacks to the Hazelwood School District for their back-to-school event. Even with virtual learning, having a backpack is important as it can bring a sense of normalcy to kids.



We know 2021 is right around the corner! On October 15, 2020 the BTSS committee held their 2021 Kick-Off Meeting. The committee used this time to recap the 2020 store and explore different scenarios for the 2021 store with the goal of keeping everyone safe and ensuring that the children in our community are receiving the necessary supplies to be confident and successful in the coming school year. - Borrowing terms during Covid that include a 2.5% interest rate vs. the program's usual 5% interest rate

What a wonderful gift for each of them to be able to receive a coat -ANY coat. This would mean these youngsters could wait in our cold St. Louis winters for the bus or walk to school in the snow, ice, and rain in a brand new coat. We often do not think of the lack of a basic need, but here is just that.

Caring for Kids helps fill urgent, basic needs as our mission, and the Store assists us with those in a very timely manner. The Back To School! Store means the world to these children. Thanks would never be enough.

125TH **STORIES: THE LIVES WE'VE TOUCHED**By Shirley Mosinger

In 1949 I was a volunteer; 20 years old, newly married and beginning my new life in St. Louis. On that day, I was babysitting with the preschoolers while their parents, Holocaust survivors, were learning English through the National Council of Jewish Women.

There was a little boy leaning over a coloring book trying to decide what color crayon to use on the animal picture. He was a toddler and was talking to me but he spoke no English. Unfortunately, I could not understand the European language he was speaking. I suggested a brown crayon to color the bear since most of the brighter colors were in use. This was my first experience with NCJW and the beginning of a long, rewarding relationship that is still treasured after 70 years.

I was vice president in 1979, and one of my duties included overseeing Council Shop which became The Resale Shop located on Lindbergh Boulevard. Council Shop was responsible for the annual Couturier sale which was - and still is - one of the most significant fundraisers for NCJW. The sale consists of the finest items that are donated, including: designer dresses, coats, suits, shoes, jewelry and more.

Betty Baron was the president at that time and Betty had boundless energy, an amazing creative spirit, and "can-do" attitude that could overcome obstacles. Betty asked friends at Brod Dugan Paint and Supply Company to donate paint for the store. She then contacted the Sigma Alpha Mu fraternity at Washington University, and a dozen young painters - mostly novices - volunteered to come. The scholars-turned painters gained experience as they worked up and down the walls. When they finished, they had a few minutes of youthful exuberance and painted each other.

When moving day came, the driver came to me and said, "You know we charge by the pound. Do you want me to load those bowling balls in the truck?" I looked over at the stack, each weighing up to 16 pounds, and said "No I'll take care of those." I counted them all, 22, and loaded them into my car and took them home. I finally found a bowling alley that said they would give me two dollars each. I drove to the bowling alley in South Saint Louis, and every time I turned a corner 22 bowling balls roared as they went from side to side in the trunk together. I consider the day a success, \$44 for a good cause and I threw in the bags as an extra for the bowling alley owner. Council shop opened at the new location shortly after.

One of the things I am most proud of concerning NCJW, is that I introduced my dear friend Anna Lee Brown to NCJW early in our friendship. In 1961 she became the youngest person to serve as president and that record still holds. I cherish the wonderful friendships, treasure the memories, and I continue to support the work today.

In 2013, I was extremely honored to receive the Hannah G. Solomon Founder's Award from NCJWSTL, which I grew up referring to as "Council," as many of my generation still do. Many of us followed in the footsteps of Hannah G Solomon, founder of NCJW, in recognizing the

need for associations for Jewish women. I was turned down for membership in a sorority in the early 1930's as an entering student at Clayton High School, because I was Jewish. These were hard lessons.

I truly believe that volunteer service is a learned activity, and I believe we learn it from others. Just as Hannah learned from the example of her family, I learned it from my parents. My father was actively involved as an officer of United Hebrew and I remember my mother volunteering in what was called a "milk station" where bottles of milk and a cookie were sold to St. Louis school children for a nickel. I know this was an NCJWSTL sponsored program.

My story of volunteering begins like so many other stories. Most of my volunteer activity has been a result of requests by friends. As soon as I was married, the late Barbara Hirsch (a former Council president, and sister-in-law of the late Wilma Messing) said to me, "Vivian, now that you are married, you join the Council." How far we've come. No one would think to say that now, but before World War II few married women worked. My first Council job was as chairperson of the Council Shop on Easton Avenue (now Martin Luther King Drive). Council was the first St. Louis organization to open a resale store like this. After my volunteering at the Shop was over, I continued on as the NCJW financial secretary and a board member.

I want to encourage everyone to be a volunteer and contribute to the community. For me, besides NCJW, I have served in leadership roles with the Jewish Hospital Auxiliary, the Jewish Light, Reproductive Health Services and Planned Parenthood (PP). Unfortunately, when I had to give up driving, my volunteer work in counseling services at PP had to end. I miss it because after 40 years it had become a habit. I want people to know how rewarding volunteering is. I'm so appreciative of the opportunities I've had to be active in the community.
