

Come learn and socialize with other NCJWSTL members as we explore fiction and non-fiction books that delve into social justice topics.



For our next book, we will be discussing housing inequality in St. Louis and beyond by reading "The Color of Law: A Forgotten History of How Our Government Segregated America" by Richard Rothstein. We will also take a look at his article, "The Making of Ferguson."

Exploding the myth of de facto segregation arising from private prejudice or the unintended consequences of economic forces, Rothstein describes how the American government systematically imposed residential segregation: with undisguised racial zoning; public housing that purposefully segregated previously mixed communities; subsidies for builders to create whites-only suburbs; tax exemptions for institutions that enforced segregation; and support for violent resistance to African Americans in white neighborhoods. A groundbreaking, "virtually indispensable" study that has already transformed our understanding of twentieth-century urban history, The Color of Law forces us to face the obligation to remedy our unconstitutional past.

#### MAKE YOUR VIEWS HEARD & MAKE A DIFFERENCE!

Sometimes it may be hard to remember that elected officials work for the public when it's difficult for the public to get in contact them - whether to express concerns or advocate for change. Here are five ways you can make your views heard by your elected officials, both on the local and national level:

#### 1 - REACH OUT TO YOUR REPS

The U.S. Government provides a public database of contact information for your elected officials at usa.gov/elected-officials. Use it. Do background research, using reliable sources, before firing off an email with your position. By the way, you can often use your elected officials' official websites to sign up for email newsletters and other updates. You may also want to follow them on social media and comment directly on their posts.

#### 2 - PLAN STRATEGIC CALLS, NOT JUST EMAILS

Phone calls from constituents are often more effective than emails because emails are depersonalized and easily ignored amid other overwhelming requests for contact. Their legislative aides also have to keep a tally of constituent phone calls. Encourage your friends to make these calls as well!

#### 3 - ATTEND TOWN HALL MEETINGS

Whether it's via Zoom, or in person post-COVID, elected officials will hold Town Hall events or Q&A sessions where the public is encouraged to attend and voice their concerns. You can usually learn about when and where these are set to take place by visiting your elected officials' websites.

#### 4 - USE DIGITAL TOOLS FOR POLICY UPDATES & ACTION

NCJWSTL utilizes a platform called FastDemocracy which enables you to track pending legislation, learn more about it, and contact your rep directly with your views. You can track the bills that NCJWSTL is following by visiting ncjwstl.org/what-we-do/advocacy.

# **CULTURAL INTELLIGENCE UPDATES**

NCJWSTL's four-session Cultural Intelligence program with Dr. Amy Narishkin of Empowering Partners was more than diversity training. It was designed to develop the intercultural competence that changes behaviors, processes, and organizational culture. Understanding how to build positive relationships while honoring differences helped participants put their good intentions into action to create a culture of belonging.



New thought patterns don't become behaviors overnight. So participants followed up monthly in small groups to share their successes and challenges in applying their new skills. Here are some of their stories:

"When I came to the training I didn't even know it was acceptable to talk about differences like race and religion. Those topics made me terribly uncomfortable. It took a while to understand that it is actually respectful to acknowledge people different from myself in the wholeness of their identity. When we say things like 'I don't see color' we might think we are being inclusive, but really we are negating part of the other person's being."

"The support of my small group helped me get comfortable with differences. And it has proved valuable in every area of my life.

The organization where I am employed is tackling these same issues of genuine inclusion, and in every management discussion I find myself modeling more comfortable, honest exchanges. I'm a long way from perfect in these skills, but I feel far more confident than before."

"I've found the Cultural Intelligence awareness helps whether I'm in the dominant or subordinate group in a given situation. I transferred from a West Coast office that actively celebrated our variety of faiths and ethnic backgrounds. My St. Louis workplace seems to assume everyone is white, upper middle class, straight and Christian. A coworker recently went from desk to desk asking each person how they are changing their Christmas observance in the pandemic. I was tempted to lecture, but instead simply answered that I don't celebrate that holiday. The next day she brought in boxes of holiday cookies and asked me politely if it would be okay for her to offer me some. Of course I was happy to share in a token of her celebration as long as we both recognized that it was not my own. Debriefing with my small group, I realized I too can ask – rather than assume – how I should best acknowledge holidays of all cultures."

"I've done other diversity and inclusion trainings and thought I was pretty adept. I quickly realized that what I thought was helpful – minimizing differences – was actually disrespectful of others' lived experiences."

"I wasn't as unbiased as I wanted to believe. For example, I unconsciously judged others in superficial ways including grammar and speech mannerisms. Now I remind myself to slow down and ask 'Does that really represent this person's intelligence or is it just a learned pattern?"

"My small group talked a lot about small touches of kindness we could extend to people we encounter, especially during a pandemic, to ease the stress. Even little things like holding doors, eye-smiles, letting others speak first in virtual meetings, acknowledging accomplishments, and sending notes of encouragement can extend beyond our immediate circle of friends to the larger world around us."





The Resale Shop is in its final stages of launching a new ecommerce website.





#### THE IMPACT OF NCJWSTL

#### A Story to Share by Toba Cohen-Dunning

I want to share a story with you about my Aunt, Jacqueline Cohen Zalmanoff, a woman whose parents emigrated to the United States from Romania in 1903 to escape the pogroms. Aunt Jackie, as she was known to our family, was the youngest of seven children (the first was born on the boat in 1902) born to Tillie and Meyer Cohen on September 16, 1919, who settled in St. Louis, Missouri in 1904. Her parents spoke only Yiddish until they passed in the 1960s. Jackie was married in the 1950s in an orthodox synagogue in St. Louis and eventually moved to Texas to be with her children. Upon her return University City later in life, she settled into an apartment in a senior living center with a meaningful Jewish population, next to her favorite Schnucks grocery store.

What mattered most to her, however, was that this senior center housed her favorite organization, the National Council of Jewish Women! If you ever wonder how much your organization means to your volunteers, please remember Aunt Jackie. It gave her a reason to get up every morning late in life, to be a part of the community she loved so dearly, to feel as though she was making a difference. When her parents emigrated to the United States in the 1900s, NCJWSTL helped them settle. She never forgot that. In her own small way, she gave back to the organization that had made an impact on her family long before she was born. Every stamp she placed, every envelope she sealed, every copy she made, every person she greeted....made a difference....to her. Aunt Jackie died in 2007 and is buried in the Beth Hamedrosh Hagodol Cemetery. Thank you NCJWSTL for making a difference and for making Aunt Jackie's life so meaningful.

Thank you Toba! Aunt Jackie has had a lasting impact and we are very grateful for her service and smiles shared over the years! Thank you to all of NJCWSTL's volunteers who make our work possible.

#### **MY NCJWSTL STORY**

#### Sue Heller Marcus and the Jean Stein Bloch Wife Widow Woman program, as written by Darien Arnstein

Sue Heller wasn't really seeking out "a project" for involvement with NCJWSTL, but a project came looking for her. The Wife Widow Woman program began in the early 1970s as the concept of Helen Kornblum, who was a practicing therapist in St. Louis and had long been involved with NCJWSTL.

Helen wanted to start a "widows' group," because in her professional capacity she felt that widows seemed to need a structured group process to move beyond their grief and to become fully functioning women. Helen asked the advice of her rabbi, Joe Rosenbloom at Temple Emanuel, who recommended that she reach out to Sue Heller for her expertise and guidance. Sue had been a widow for eleven years at that point, and was able to provide the perspective of a widow for building this program, along with Helen's professional expertise. They proposed the first session to then-President Lynn Lyss, who was impressed with their concept and embraced the idea. Betty Baron, during her term as President, provided encouragement for its continuation.

The basic outline of the program, which they named Wife Widow Woman, was to assist recently widowed women, who had previously only identified as wives, to begin to view themselves as women, not as widows, functioning in the new landscape of their situation. The first group met at night in the women's homes. Sue and Helen felt that meeting in homes was more personal, and gave each woman the opportunity to be the "hostess" using their own china and building their self-esteem as well as bonding as a group. Sue recalls that, in those days, some women wouldn't even go out to dinner by themselves with other women.

The priority of the program was that everything shared was kept confidential within the group. The program was time-limited, free of charge, and open to any widow in the St. Louis area, Jewish or non-Jewish, of any background and certainly not limited to NCJWSTL members. Helen volunteered her expertise as therapist and when Sue became the "lay leader" as a widow herself she was also a volunteer. Together Sue and Helen led these groups for seven or eight years, before turning over the program to Doris Diamond, Thelma Edelstein, Carole Simon, and subsequently to Eleanor Rosenbaum. The program has adapted and grown to meet the current times, now meeting both daytime and evening, with paid professional therapists along with a widow who facilitates as a volunteer (much as Sue Heller did in the beginning). The program is currently run by the Wife Widow Woman Board, which does outreach to newly widowed women.

We celebrate the involvement of Nardie and Sally Stein, who have provided important financial funding for the program. At their urging, Nardie's sister, Jean Stein Bloch, moved to St. Louis in the mid-1970s after being recently widowed, and joined WWW where she found life-long friends and others coping with loss. Jean later "paid it forward" by volunteering as a co-leader for future groups.

Many women in the St. Louis community give high praise to the Wife Widow Woman program (now named for Jean Stein Bloch). Sue Marcus recalls hearing from numerous women, some whom she really didn't know well, that "the program just saved my life." Over 900 women have participated in the Jean Stein Bloch Wife Widow Woman program since it began in 1976, and their lives have been enriched. This is truly exemplary of the NCJWSTL mission, to improve the quality of life for women, children, and families. Thank you to Sue Heller Marcus and Helen Kornblum, for inaugurating this most impactful service to our community, and to the many volunteers who keep it running to this day. The Jean Stein Bloch Wife Widow Woman continues as one of NCJWSTL's longest-enduring, and well-loved community service projects.

### NEWSTEAD FAMILY: MULTI-GENERATIONAL INVOLVEMENT

The Newstead family, parents Sherri and Steve and children Andrea and Todd, support each other as part of a close family network and have generously supported the National Council of Jewish Women St. Louis (NCJWSTL) for many years with their time and talent.

Sherri Newstead got involved over 40 years ago and is still volunteering today, bringing her devoted family along with her. She began her connection to NCJWSTL by joining the "Evening Group" which was a social group for young mothers. Soon after she transitioned to the Board Executive Committee and became VP of Membership. Sherri traveled to other cities with NCJW chapters and discovered Junior Council, a community service and advocacy group for girls from 5th to 12th grade. The hope was to get them involved at an early age and teach them the value of giving back to the community in a meaningful way. Many of Sherri's "girls" went on to become Board members and are still active today. Their daughter Andrea got involved in fifth grade, became President of Junior Council, and a member of the national Junior Council board. She stayed involved all through high school and even came back after college (while living in Chicago) to volunteer at the Back to School! Store (BTSS).

Sherri joined the BTSS steering committee at its inception and continues to volunteer with her family members every year. Andrea moved back to St. Louis after graduating college and soon after followed in her mom's footsteps by joining the BTSS steering committee. She ended up chairing BTSS for six years before she became the Vice President of Community Service overseeing both BTSS and Kids Community Closet. Sherri's husband Steve started by volunteering at BTSS and now serves on the Advisory Committee with other community leaders and volunteers. In recognition of their outstanding community service, Sherri and Steve Newstead were honored by NCJWSTL in 2014 with the Volunteer Service Award. Andrea received the Emerging Leader award in 2011 and the Leadership award in 2015. Their son Todd and his wife Jessica have both volunteered for BTSS for years. Part of Todd's job is to take Fredbird, St. Louis Cardinals mascot, around to greet all the kids who are shopping for school in the store. Todd and Jessica both work at Stifel, who has been a longtime sponsor and also provided financial literacy coloring books for each child to take home. During COVID the whole family loaded up their cars and delivered backpacks filled with school supplies and drove them to community organizations supported by NCJWSTL to make sure kids felt prepared and excited for the first day of school. Andrea's son, Evan, and his cousin, Davis, 22 months and 3 1/2 years, were proud helpers too!

The family mantra is: Once one family member gets involved, we all get involved. And they are passionately involved. Recently Sherri and Steve decided to become *Partners for Our Future* by giving a Legacy Circle gift to the *125th Anniversary Partners for Our Future Endowment Campaign*. #### **NANCY LITZ**

Nancy Litz is a "giver" to NCJWSTL with her time, talent, and treasure ...and has a story that is worth telling.

She was born into a family that taught about supporting her community. However, as an adult she spent over 20 years in two consecutive relationships that were verbally, emotionally, and financially controlling to the extreme. Nancy had very limited access to money...even her own earnings...so her contributions were limited to the "talent" category. When she finally divorced, she was raising three teenagers alone on a crazy-tight budget. "So my story about money was rooted in fear and scarcity. And my story about my own abilities was about the same."

Nancy encountered NCJWSTL women on a Planned Parenthood Lobby Day trip, and later was invited to a Lunch & Learn - and became hooked! "All my big issues under one umbrella - Reproductive Health, LGBTQ and Racial Equity, with the Mission to Improve the Lives of Women, Children and Families." She was invited to participate in an NCJWSTL Leadership Class and eventually served on the Board and as an officer. "Of course I gave to the NCJWSTL Annual Campaign but it was minimal. Although I always aspired to become a Hannah G. Solomon donor (\$1,000), I certainly did not see that as possible."

"NCJWSTL helped me to gradually see myself in a whole new way. People believed in me, offered me responsibility, supported my efforts, and provided positive feedback. It was a long but gratifying journey, and both my confidence and business success (wardrobe consultant) started to grow. And, I felt the time had come that I could be a Hannah G. donor. Having the option to pay monthly made all of the difference in the world for me!" And, after a few months, Nancy felt comfortable writing an annual check.

"Because I am a VP on the board, I felt responsible to make a visible contribution to the 125th campaign - but the lowest category was far outside my comfort zone. Again the segmented option made it less scary... half now and half in equal increments over the next 5 years. I thought about how much I believe in the mission and how much I want to ensure that it continues. I thought about the incredible gift of growth the organization has given me. I took the plunge, and it felt so good!"

Nancy acknowledges that she would not be the person she is today, or have the increasing business success, were it not for NCJWSTL. The organization and individuals within it have pushed her out of her 'scaredy-cat little box' and taught her to play a bigger game, "I'm so excited about the things NCJWSTL will do in the future to benefit my daughters and all the young women and children coming along behind us."

Ironically, the COVID situation has turbo-charged her wardrobe consulting practice. Now she can work virtually with clients all across the country and be far more profitable. In retrospect, Nancy shares, "It didn't seem right to profit so much from a pandemic that caused such devastation for others, so I've increased my NCJWSTL giving, and added the food pantry to my list. Knowing how many families needed food assistance, I first volunteered in the warehouse. Then I thought of pledging a portion of fees from my new online classes as a financial donation. My class participants love it, and many have been motivated to volunteer or donate to food efforts in their own communities too. I guess giving is one thing that is contagious ... in a good way."

NCJWSTL is so fortunate to have the time, talent and treasure of Nancy Litz as we move forward in 2021 and beyond with our mission to improve the lives of women, children, and families! Thank you to Nancy and everyone who supports NCJWSTL as we **Partner for Our Future** together.


