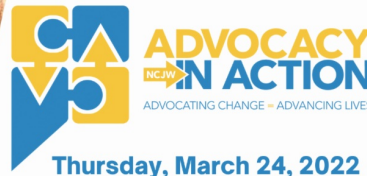

Missouri's initiative petition system has been in place for 115 years and allows citizens to put an issue on the ballot for a statewide vote. This critical tool, used through the years by citizens from all political persuasions is now under attack by lawmakers who want to curtail the people's power.

The legislature is currently proposing 20 or so different bills that would make it harder to get an issue on the ballot and increase the threshold for an initiated measure to pass once on the ballot. For some perspective, a large majority of voters recently approved a higher minimum wage, Medicaid expansion, and medical marijuana through the initiative petition process. Under the proposed new threshold, each would have failed.

For our March Lunch and Learn, NCJWSTL is excited to welcome Ashton Kuehnel, who will present on why this is happening and what we can do about it. Ashton is a Grassroots Organizer with the Sierra Club, Missouri Chapter. In her role Ashton has organized around Medicaid Expansion, a just transition to clean, renewable energy, and voting protections. She lives in St. Louis City and is a Saint Louis University alum.

Judge Ketanji Brown Jackson to SCOTUS!

NCJWSTL is thrilled with the news that President Biden nominated [Judge Ketanji Brown Jackson](#) to the United States Supreme Court. If confirmed, Judge Jackson would be the first Black woman in history to sit on the Court.

Judge Ketanji Brown Jackson has a wealth of experience having served as a federal district court judge in Washington, DC since 2013 and circuit court judge on the US Court of Appeals for the District of Columbia Circuit since 2021, our nation's second-highest court. A former public defender, assistant special counsel on the US Sentencing Commission, and law clerk for Justice Stephen Breyer, Jackson has a record of supporting reproductive healthcare, civil rights, disability rights, labor rights, and other issues.

Human Trafficking isn't something that only occurs in other places; it's here right in our area and we need not only to be aware of this human slavery, but we must actively work against it. Trafficking can take many forms: sex, labor, international, domestic, agricultural, etc., and is happening in our midst.

The first session will feature presentations from NCJWSTL, the International Institute, law enforcement, and a trafficking survivor. They will share the realities of trafficking in the St. Louis area and suggest ways you can possibly help.

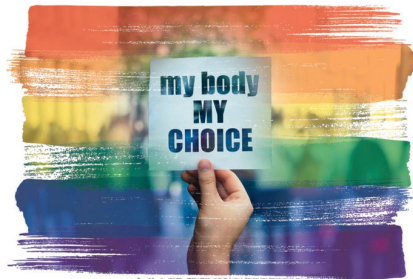
