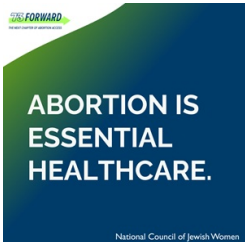

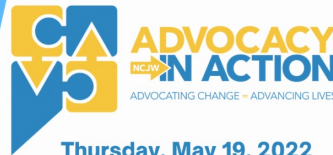
Shaare Emeth, and Dana Sandweiss, Attorney and Founder of AccessMO.

**If the Supreme Court overturns Roe v. Wade, it would not outlaw abortion. Instead, states would be able to individually determine the procedure's legality.**

Thirteen states across the country, including Missouri, have signaled their readiness to ban abortion by passing

so-called trigger laws, which would effectively ban abortions almost immediately after a decision from the Supreme Court to overturn Roe v. Wade.
