



#### Legislation Watch - Take Action Today!

NCJWSTL is closely monitoring the following legislation this week and we are asking you to take action:

**HB** 485 - This bill would allow the concealed carrying of firearms in churches and other places of worship by a person with a valid concealed carry permit.



**HB 701** - This bill is an anti-Red Flag Law bill. Red Flag Laws allow loved ones or law enforcement to petition a court for an order to temporarily prevent someone in crisis from accessing guns. If you recall, many believe the shooting at Central Visual and Performing Arts School could have been prevented had a Red Flag Law been in place.

These two bills are up for a hearing on Wednesday afternoon. Please contact members of the Missouri House Emerging issues Committee and urge them to vote NO on HB 485 and HB 701. <u>Click here</u> for the committee's contact information.

**HJR 43** - This bill would attack our citizen initiative process by making it harder to get a citizen initiative on the ballot and more difficult for measures to pass once on the ballot.

## Tell Congress: It's Beyond Time for Equal Pay in our Country!

Equal Pay Day 2023 was March 14th. Pay discrimination is a persistent problem in our country that perpetuates poverty and robs women of what they've earned. The <u>Paycheck Fairness</u> <u>Act</u> would update and strengthen the Equal Pay Act of 1963 to ensure that it provides robust protection against sex-based pay discrimination.



Among other provisions, this bill bars retaliation

against workers who voluntarily discuss or disclose their wages and closes loopholes that have allowed employers to pay women less than men for the same work.

Sixty years after passage of the Equal Pay Act, the wage gap persists, with dire impacts on women and families. Women working full-time, year-round are typically paid only 84 cents for every dollar paid to men.

**Women of color experience the most significant losses.** Asian American, Native Hawaiian and Pacific Islander (AANHPI) women make 80 cents for every dollar paid to white men, Black women are paid 64 cents, Latinas are paid 54 cents and Native American women are paid just 51 cents.

Lamar Johnson was convicted in 2004 of shooting a man several times in broad daylight. No physical evidence connected him to the incident. After spending 13 years in prison, the state's attorney's office concluded that eyewitness testimony during the trial was flawed and that the two witnesses who identified Johnson as the gunman had said that he merely "looked similar" to the shooter.

One of the attorneys instrumental in securing his freedom is Lindsay Runnels, whom we are thrilled to welcome as our April Lunch and Learn speaker. Runnels is an attorney at Morgan Pilate, LLC in Kansas City, Missouri. She specializes in trial and post-conviction criminal defense, innocence, and civil rights litigation. She is a former clinical professor at the University of Missouri-Kansas City School of Law and University of Missouri-Columbia School of Law where she was the director of the Wrongful Convictions Clinic in partnership with the Midwest Innocence Project.

Anti-vaxxers hoping to convince people that COVID vaccines are linked to sudden deaths among younger people have invoked the term while trying to exploit tragic events like the death of soccer journalist Grant Wahl, or Damar Hamlin suffering a cardiac arrest during an NFL game. Though that theory has no scientific evidence to support it, the "died suddenly" rhetoric has gained a lot of traction on social media. How
