Hundreds of kidnapped civilians are being held hostage by Hamas in unfathomable circumstances. Urge Congress to Support Israel



The surprise attack on Israel is unprecedented and the magnitude is like nothing we have ever seen during Israel's history. Hamas deliberately planned this brutality for a day of major religious significance for Jews, and its shockwaves are felt in Jewish communities around the globe.

As we learn of more than 1,200 Israelis killed, more than 2,300 wounded, and more than 150 taken hostage in the attack on Israel by Hamas,

Israel needs unequivocal support from the United States. Members of Congress have

the opportunity to make a difference with a new pro-Israel resolution circulated by House Foreign Affairs Committee Chairman Michael McCaul (R-TX) and Ranking Member Greg Meeks (D-NY) that:

- Condemns Hamas' brutal war on Israel.
- Stands with Israel and reaffirms Israel's right to self-defense.
- Reaffirms the United States' commitment to Israel's security and stands ready to assist Israel with emergency resupply and other security, diplomatic, and intelligence support.
- Urges full enforcement of US sanctions against Iran to prevent Iran's funding of terrorist groups including Hamas and Palestinian Islamic Jihad.

The resolution is expected to be introduced immediately. It is important our lawmakers are on record supporting Israel, committed to putting the full weight of the United States behind Israel's right to defend itself.

During 2023, members of over 10 southern and midwestern state legislatures considered or attempted to close their primaries. Had they been successful, 25,000,000 unaffiliated and independent voters would have been completely disenfranchised from voting and tens of millions more party voters would have been



denied any meaningful choices at the ballot box. Anticipating that efforts to close the primary in 2024 will intensify, The Missouri Voter Protection Coalition (MOVPC) and Open Primaries (OP) are partnering to build awareness about this **attack on democracy** and what we can do to oppose it.

The event's speakers are voting rights experts Denise Liberman and Jeremy Gruber. During the webinar, they will explore how the closed primary efforts are an emerging form of voter suppression against communities of color, how this fight is shaping up in several states (including MO) and what we can do to oppose legislative strategies aiming to close primaries.

ADD YOUR NAME and Help Us Oppose Censorship of Our Public Libraries

To protect libraries throughout Missouri, including those at public schools, NCJWSTL has helped convene a statewide coalition of individuals and organizations called Right to Read. The coalition will oppose any legislative, state policy or other effort to restrict access to materials at public libraries; the coalition has the utmost confidence in trained, experienced librarians and educators to evaluate and select materials in the libraries' collection.

Did you know?

- As a result of a Missouri law enacted in August 2022 restricting some types of materials in public schools, librarians fearful of criminal prosecution have removed nearly 300 titles from school library shelves.
- Under an administrative rule imposed by Secretary of State Jay Ashcroft, all public libraries must have submitted by July 31 how they will comply with the vaguely written rule. Failure to comply could result in loss of state funding, which comprises a significant portion of small libraries' budgets.
- Missouri is among the nation's top book banning states, **especially regarding** restricting access to books about gender, sexuality and race in public schools.

More attempts will likely be made in the 2024 Missouri legislative session to suppress First Amendment rights. Free and open access to materials at our public libraries is an essential aspect of our democracy.

This effort is vitally important in the wake of last year's Supreme Court decision overturning Roe vs. Wade, especially in states like Missouri where abortion is illegal. Everyone should have the right to determine when and if they wish to start a family, and emergency contraception is vital in preventing unwanted pregnancies.
