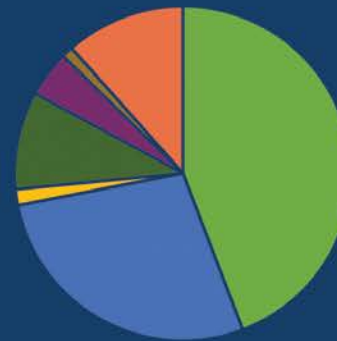

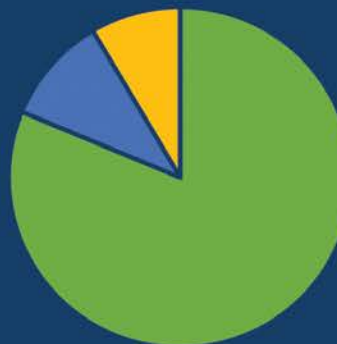

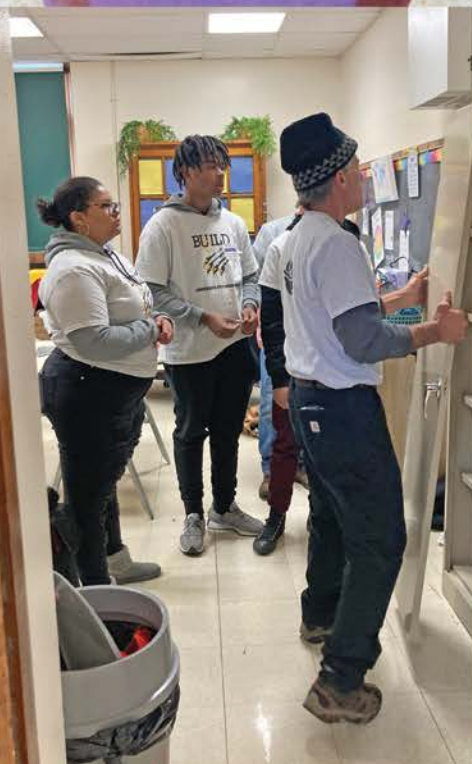

# ADVOCACY

-  21 trips to Jefferson City to speak with decision makers and lawmakers
-  Presented testimony on 28 bills in the State Legislature
-  3,000 advocates rallied against attacks on the LGBTQ+ community, reproductive justice, and IP process
-  275 "Calls to Action" were delivered through weekly "5-Ways to Advocate" eblast

# COMMUNITY IMPACT

-  44 Healing Hearts Bank loans furthering financial independence were made totaling \$25,600
-  HHB achieved a milestone: we've provided over \$100,000 in loans! As of June 16, 235 loans totaling \$105,864 have been issued
-  108 vouchers for the Resale Shop were distributed to people in need totalling \$7,210
-  Jean Stein Bloch Wife Widow Woman expanded to 4 sessions annually

## Back to School! Store by the numbers:






-  2,000 children were provided coats, backpacks, school supplies, books, dental kits, socks, and more
-  500+ volunteers assisted with the 2023 Store
-  70 agencies throughout St. Louis City and County partnered on BTSS

## 29 Kids Community Closets, serving 33 schools, distributed essential items to students that needed them most:

-  1,146 Shirts
-  1,636 Pairs of pants
-  1,359 Winter coats
-  1,300+ Hats and pairs of gloves
-  275 Pairs of socks
-  500 Dental kits







# THE RESALE SHOP

-  Annual sales at The Resale Shop during 2022-2023 grew 25%
-  170,173 items sold with profits supporting women, children, and families, a 13% increase
-  8,626 people made donations to the Resale Shop during 2022-2023, an 11.5% increase
-  Ecommerce (ShopTheResaleShop.org) drove 59,242 visitors to our site
-  The Resale Shop was voted "Finalist" in Best Resale Shop category by voters in the St. Louis Magazine A-List awards

## TIME & TALENT

-  5,000 members and supporters donated their efforts to supporting women, children, and families in our community
-  Over 25,000 volunteer hours were dedicated to the mission of NCJWSTL
-  Over 30 scarves and lap blankets were hand knitted by our volunteers and delivered to clinics to help keep patients warm after their procedures
-  1,409 members of NCJWSTL includes 525 regular, supporting, and sustaining members and 854 life members

## HIGHLIGHTS

-  Partnership with Royal Banks of Missouri doubling our distribution of the Family Resource Guide to those who interact directly with children and families in our community. Guides will also be available at all Royal Banks of Missouri branch offices.
-  Chosen by Nextstar Fox 2 as partner for their annual Founder's Day of Caring. Fox 2 employees teamed up with NCJWSTL to sort coats, fill backpacks, and box books for Back to School! Store.
-  Established the Community Partnership Award presented during Installation to a non-member or community-based organization that supports our programs and projects through collaboration, coalition, or other partnership.
-  Partnered with Angels' Arms to set up two different houses to help "make their house a home" with volunteers providing bedding, towels, and kitchen supplies allowing them to move in seamlessly.
