- If you are collecting signatures and need your sheets notarized, a notary is available at the NCJWSTL office on Mondays and Thursdays between 8:00 AM - 4:00 PM and Wednesdays between 11:00 AM - 7:00 PM.

Legislation Watch - Take Action Today!

NCJWSTL is closely monitoring the following legislation this week and we are asking you to take action:

Bills we are advocating FOR this week:

HB 1999 - This bill allows school districts to include instruction on LGBTQ contributions to society. Although it has been introduced, it has not yet been assigned to a committee, but you can contact your legislators by [clicking here](#) to urge them to support HB 1999 when it's assigned to a committee.

HB 2478 - This bill prohibits discrimination based on sexual orientation or gender identity. Otherwise known as the Missouri Non-Discrimination Act (MONA), NCJWSTL and our coalition partners have been trying to pass this legislation for over 20 years. MONA has not been assigned to a committee yet, but you can contact your legislators by [clicking here](#) to urge them to support HB 2478 if and when it is.

Below are the bills we are advocating AGAINST this week:

HB 1650 - This bill would ban drag shows in Missouri. This is not only a blatant attack against the LGBTQ community, it is also unconstitutional. HB 1650 was heard last week in the [Missouri House Special Committee on Public Policy](#)* and NCJWSTL submitted testimony in opposition. Please contact members of the committee by [clicking here](#)* and urge them to vote NO on HB 1650 if it comes up for a vote.

SJR 79 - This bill has passed out of the Senate and has moved on to the House. If passed, it would increase the voting threshold for ballot measures to need over 50% of the statewide vote, plus win in a majority of the eighty-two House districts. Such a change could make it nearly impossible for any future ballot measure to pass as 20% of the voters could overturn the will of the rest of the state. Please contact your Missouri representative by [clicking here](#) and urge them to vote no on SJR 79, as well as on any measures to change the initiative petition process.

HB 2498 - This bill requires public libraries that are authorized to levy or collect taxes to be governed by an elected library board. It would be disastrous for public libraries because it would give the board power to select books, make personnel decisions, etc. This bill has been voted out of committee. Please contact your Missouri representative by [clicking here](#) and urge them to vote NO on HB 2498 if and when it comes to the House floor.

The Alabama Supreme Court recently issued a ruling that declared frozen embryos to be children and that the discarding of frozen embryos constitutes the wrongful death of a minor. This decision was clearly in favor of Christian theology, not even trying to hide their reasoning. Indeed, the Chief Justice referenced God 41 times and repeatedly quoted the Bible in his

A court decision that favors one religion over another goes against the principles of our Constitution and disproportionately impacts people from various minority religious backgrounds, including Jewish communities, as well as others who need access to critical reproductive technologies, like LGBTQ couples and those who depend on IVF to start and build their families.

ADD YOUR NAME and Help Us Oppose Censorship of Our Public Libraries

To protect libraries throughout Missouri, including those at public schools, NCJWSTL has helped convene a statewide coalition of individuals and organizations called Right to Read. The coalition will oppose any legislative, state policy or other effort to restrict access to materials at public libraries; the coalition has the utmost confidence in trained, experienced librarians and educators to evaluate and select materials in the libraries' collection.



Did you know?

- As a result of a Missouri law enacted in August 2022 restricting some types of materials in public schools, **librarians fearful of criminal prosecution have removed nearly 300 titles** from school library shelves.
- Under an administrative rule imposed by Secretary of State Jay Ashcroft, all public libraries must have submitted by July 31 how they will comply with the vaguely written rule. **Failure to comply could result in loss of state funding**, which comprises a significant portion of small libraries' budgets.
- Missouri is among the nation's top book banning states, **especially regarding restricting access to books about gender, sexuality and race in public schools.**

More attempts will likely be made in the 2024 Missouri legislative session to suppress First Amendment rights. Free and open access to materials at our public libraries is an essential aspect of our democracy.

Get FREE Emergency Contraception at NCJWSTL!



NCJWSTL is thrilled to announce that we have partnered with the [Missouri Family Health Council](#) (MFHC) to distribute **FREE emergency contraception kits!** This effort is vitally important in the wake of last year's Supreme Court decision overturning Roe vs. Wade, especially in states like Missouri where abortion is illegal. Everyone should have the right to determine when and if they wish to start a family, and emergency contraception is vital in preventing unwanted pregnancies.

Also known as the morning-after pill, or by the brand name Plan B, the emergency contraception pill is an over-the-counter form of birth control that can be taken up to five days after unprotected sex to avoid pregnancy. The goal of this effort is to reduce geographic and financial barriers Missourians face in accessing emergency contraception pills.

While supplies last, MFHC, NCJWSTL and other partner organizations are offering free EC kits to anyone of any age. **Feel free to stop by the NCJWSTL office to pick up your kit - for you or a loved one.**

At 9:05 a.m. on Thursday, Oct. 22, 2020, a group of anti-abortion extremists from at least six states forced their way into the Washington Surgi-Clinic, a facility that provides abortion care in Washington, D.C. Some bound themselves together with chains, ropes and bike locks to block access to the clinic's patient area. Others obstructed access to its employee entrance. Several used their bodies to try to prevent patients from entering the facility. Still more moved about assaulting patients—mostly verbally, but in one case physically—in the waiting room, a

hallway and even in the small elevator leading to the fourth-floor clinic.
