



# **Urge Congress to Support the Right to Contraception Act**

Guided by our Jewish values, National Council of Jewish Women has long affirmed the need for access to family planning, including contraceptives. The <u>Right to Contraception Act</u> would reaffirm the right to use birth control first recognized by the Supreme Court more than half a century ago in *Griswold v. Connecticut*.



This bicameral legislation would protect unrestricted

access to contraception in the face of growing threats by ensuring the legal right for individuals to use contraception and practitioners to provide contraception and related information. Enshrining the right to contraception into federal law would reverse steps already taken by state legislatures to restrict access to contraceptives and ensure that any future court rulings would not endanger access to this essential health care.

## **Know Your Missouri Voting Information**



**Missouri's primary election is coming up on August 6th\*** and will determine which candidates appear on November's general election ballot. No matter what zip code we live in or the color of our skin, our voices are equal at the ballot box, and we could all must make sure our voices are heard!

#### **Essential Information:**

- Absentee voting Absentee voting for August 6th will begin on **Tuesday, June** 25th! You can vote absentee by mail or in person. The deadline to request an absentee ballot by mail is **Wednesday, July 17th.** You can cast an absentee ballot in-person up until **Monday, August 5th.**
- In-person on Election Day Polls are open from 6:00 AM 7:00 PM. To find your polling place, please <u>click here</u>.
- In order to avoid long waits on Election Day, the Board of Elections encourages you to vote absentee. If you vote absentee by mail, your ballot must be

notarized. This can be done either at the NCJWSTL office (contact **Jen Bernstein** for more information) or at any St. Louis County Library.

## ADD YOUR NAME and Help Us Oppose Censorship of Our Public Libraries

To protect libraries throughout Missouri, including those at public schools, NCJWSTL has helped convene a statewide coalition of individuals and organizations called Right to Read. The coalition will oppose any legislative, state policy or other effort to restrict access to materials at public libraries; the coalition has the utmost confidence in trained, experienced librarians and educators to evaluate and select materials in the librar

educators to evaluate and select materials in the libraries' collection.

Did you know?

- As a result of a Missouri law enacted in August 2022 restricting some types of materials in public schools, **librarians fearful of criminal prosecution have removed nearly 300 titles** from school library shelves.
- Under an administrative rule imposed by Secretary of State Jay Ashcroft, all public libraries must have submitted by July 31 how they will comply with the vaguely written rule. **Failure to comply could result in loss of state funding**, which comprises a significant portion of small libraries' budgets.
- Missouri is among the nation's top book banning states, **especially regarding** restricting access to books about gender, sexuality and race in public schools.

More attempts will likely be made in the 2024 Missouri legislative session to suppress First Amendment rights. Free and open access to materials at our public libraries is an essential aspect of our democracy.

#### Get FREE Emergency Contraception at NCJWSTL!

NCJWSTL is thrilled to announce that we have partnered with the <u>Missouri Family Health Council</u> (MFHC) to distribute **FREE emergency contraception kits**! This effort is vitally important in the wake of last year's Supreme Court decision overturning Roe vs. Wade, especially in states like Missouri where abortion is illegal. Everyone should have the right to determine when and if



they wish to start a family, and emergency contraception is vital in preventing unwanted pregnancies.

Also known as the morning-after pill, or by the brand name Plan B, the emergency contraception pill is an overthe-counter form of birth control that can be taken up to five days after unprotected sex to avoid pregnancy. The goal of this effort is to reduce geographic and financial barriers Missourians face in accessing emergency contraception pills.

While supplies last, MFHC, NCJWSTL and other partner organizations are offering free EC kits to anyone of any age. Feel free to stop by the NCJWSTL office to pick up your kit - for you or a loved one.
