A couple of weeks ago, Louisiana Gov. Jeff Landry signed a bill into law mandating that all public elementary, secondary and postsecondary schools display (the state's officially approved version of) the Ten Commandments in every classroom.



This law violates the separation of church and state and is blatantly unconstitutional.

That's why Americans United, along with the American Civil Liberties Union, the American Civil Liberties Union of Louisiana and the Freedom from Religion Foundation are suing Louisiana.

Know Your Missouri Voting Information

Missouri's primary election is coming up on August 6th* and will determine which candidates appear on November's general election ballot. No matter what zip code we live in or the color of our skin, our voices are equal at the ballot box, and we all must make sure our voices are heard!





NCJWSTL is encouraging all of our members, friends and supporters to confirm their <u>voter</u> registration is up to date.

Voter registration must be completed by: July 10th for the August 6th Primary and October 9th for the November 5th General Election.

You do not need a photo ID when registering to vote unless you have never registered to vote before.





You can vote absentee by mail or in person. If you vote absentee by mail, your ballot must be notarized and received by the Board of Elections by **the day before the election**. Notaries are available at all STL County Public Libraries and NCJWSTL.

For the August 6th Primary Election

First day to vote absentee - June 25th Two weeks of no-excuse, in-person absentee voting -July 23rd - Aug 5th

Mail-in Absentee request due to election authority -July 24th

For the November 5th General Election

First day to vote absentee - Sept 24th
Two weeks of no-excuse, in-person absentee voting Oct 22nd - Nov 4th
Mail-in Absentee request due to election authority -

Antisemitism has been steadily rising in the United States and has skyrocketed since the terrorist attack on Israel launched by Hamas on October 7, 2023. Right now, nowhere in the United States feels safe for Jewish people. Antisemitic hate threatens us in schools and at universities, at our synagogues, at work, and in our neighborhoods. We must not allow this to become the status quo, and now Congress has an opportunity to take action.

The bipartisan <u>Countering Antisemitism Act</u> would ensure that the current administration and any future administration have the tools they need to fight antisemitism. This historic legislation is the most far-reaching antisemitism initiative ever to be introduced in Congress. The legislation would also promote Holocaust education, help elected officials better understand the threat of antisemitic violent extremism and online hate, and formally establish Jewish American Heritage Month in

law.

To protect libraries throughout Missouri, including those at public schools, NCJWSTL has helped convene a statewide coalition of individuals and organizations called Right to Read. The coalition will oppose any legislative, state policy or other effort to restrict access to materials at public libraries; the coalition has the utmost confidence in trained, experienced librarians and



educators to evaluate and select materials in the libraries' collection.

Did you know?

- As a result of a Missouri law enacted in August 2022 restricting some types of materials in public schools, librarians fearful of criminal prosecution have removed nearly 300 titles from school library shelves.
- Under an administrative rule imposed by Secretary of State Jay Ashcroft, all
 public libraries must have submitted by July 31 how they will comply with the
 vaguely written rule. Failure to comply could result in loss of state funding,
 which comprises a significant portion of small libraries' budgets.
- Missouri is among the nation's top book banning states, especially regarding restricting access to books about gender, sexuality and race in public schools.

More attempts will likely be made in the 2024 Missouri legislative session to suppress First Amendment rights. Free and open access to materials at our public libraries is an essential aspect of our democracy.

Get FREE Emergency Contraception at NCJWSTL!



NCJWSTL is thrilled to announce that we have partnered with the <u>Missouri Family Health Council</u> (MFHC) to distribute **FREE emergency contraception kits**! This effort is vitally important in the wake of last year's Supreme Court decision overturning Roe vs. Wade, especially in states like Missouri where abortion is illegal. Everyone should have the right to determine when and if they wish to start a family, and emergency contraception is vital in preventing unwanted pregnancies.

Also known as the morning-after pill, or by the brand name Plan B, the emergency contraception pill is an over-the-counter form of birth control that can be taken up to five days after unprotected sex to avoid pregnancy. The goal of this effort is to reduce geographic and financial barriers Missourians face in accessing emergency contraception pills.

While supplies last, MFHC, NCJWSTL and other partner organizations are offering free

EC kits to anyone of any age. Feel free to stop by the NCJWSTL office to pick up your kit - for you or a loved one.



In the wake of the Supreme Court's June 2022 Dobbs decision, as dozens of abortion clinics shut down in states with total or near-total abortion bans, reproductive justice advocates warned that the closures wouldn't just affect patients seeking to terminate their pregnancies. Family planning clinics have historically provided more than abortion services, often offering basic gynecological health care for women. And without abortion as an option,

many of them would be forced to carry unwanted pregnancies to term.
