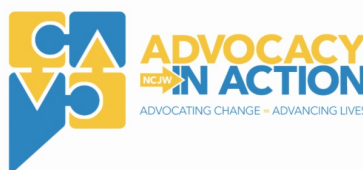




August Lunch and Learn: The Intersection of Bullying and Antisemitism with Lauren Abraham

We have unfortunately heard countless stories of severe and persistent bullying and harassment of Jewish students since the October 7, 2023, attack by Hamas against Israel. These incidents are deeply troubling, and the rise in antisemitism demands our attention and action.

Bigotry is often the result of a lack of knowledge and familiarity. As a response, JCRC St. Louis developed Student to Student, a program that reduces stereotypes and prejudice in the students it reaches. Initially funded in 1992 by a planning grant of the Jewish Federation, Student to Student has reached thousands of students in area schools that lack a Jewish presence. Young people who have had this experience can now put a "human face" to Judaism—the best antidote to bigotry and intolerance.

We are so excited to hear from Student to Student Coordinator Lauren Abraham and several of her student leaders for our August Lunch and Learn. They will explain how they are confronting antisemitism and bullying, one presentation at a time.

Take Action Today to Counter Antisemitism



As mentioned above, antisemitism has been steadily rising in the United States and has skyrocketed since the terrorist attack on Israel launched by Hamas on October 7, 2023. Antisemitic hate threatens us in schools and at universities, at our synagogues, at work and in our neighborhoods. We must not allow this to become the status quo, and now Congress has an opportunity to take action.

The bipartisan [**Countering Antisemitism Act**](#) would ensure that the current administration and any future administration have the tools they need to fight antisemitism. This historic legislation is the most far-reaching antisemitism initiative ever to be introduced in Congress. The legislation would also promote Holocaust education, help elected officials better understand the threat of antisemitic violent extremism and online hate, and formally establish Jewish American Heritage Month in law.

Know Your Missouri Voting Information - No-Excuse Early Voting Starts Tomorrow!

Missouri's primary election is coming up on August 6th* and will determine which candidates appear on November's general election ballot. No matter what zip code we live in or the color of our skin, our voices are equal at the ballot box, and we all must make sure our voices are heard!



STEP 1

Voter Registration

NCJWSTL is encouraging all of our members, friends and supporters to confirm their [voter registration is up to date](#).

Voter registration must be completed by: **July 10th** for the **August 6th Primary** and **October 9th** for the **November 5th General Election**.

You do not need a photo ID when registering to vote unless you have never registered to vote before.

STEP 2

Absentee Voting

You can vote absentee by mail or in person. If you vote absentee by mail, your ballot must be notarized and received by the Board of Elections by **the day before the election**. [Notaries are available at all STL County Public Libraries and NCJWSTL.](#)

For the August 6th Primary Election

First day to vote absentee - June 25th
Two weeks of no-excuse, in-person absentee voting - July 23rd - Aug 5th
Mail-in Absentee request due to election authority - July 24th

For the November 5th General Election

First day to vote absentee - Sept 24th
Two weeks of no-excuse, in-person absentee voting - Oct 22nd - Nov 4th
Mail-in Absentee request due to election authority - Oct 23rd

To protect libraries throughout Missouri, including those at public schools, NCJWSTL has helped convene a statewide coalition of individuals and organizations called Right to Read. The coalition will oppose any legislative, state policy or other effort to restrict access to materials at public libraries; the coalition has the utmost confidence in trained, experienced librarians and educators to evaluate and select materials in the libraries' collection.



Did you know?

- As a result of a Missouri law enacted in August 2022 restricting some types of

materials in public schools, **librarians fearful of criminal prosecution have removed nearly 300 titles** from school library shelves.

- Under an administrative rule imposed by Secretary of State Jay Ashcroft, all public libraries must have submitted by July 31 how they will comply with the vaguely written rule. **Failure to comply could result in loss of state funding**, which comprises a significant portion of small libraries' budgets.
- Missouri is among the nation's top book banning states, **especially regarding restricting access to books about gender, sexuality and race in public schools.**

More attempts will likely be made in the 2024 Missouri legislative session to suppress First Amendment rights. Free and open access to materials at our public libraries is an essential aspect of our democracy.

Get FREE Emergency Contraception at NCJWSTL!



NCJWSTL is thrilled to announce that we have partnered with the [Missouri Family Health Council](#) (MFHC) to distribute **FREE emergency contraception kits!** This effort is vitally important in the wake of last year's Supreme Court decision overturning Roe vs. Wade, especially in states like Missouri where abortion is illegal. Everyone should have the right to determine when and if they wish to start a family, and emergency contraception is vital in preventing unwanted pregnancies.

Also known as the morning-after pill, or by the brand name Plan B, the emergency contraception pill is an over-the-counter form of birth control that can be taken up to five days after unprotected sex to avoid pregnancy. The goal of this effort is to reduce geographic and financial barriers Missourians face in accessing emergency contraception pills.

While supplies last, MFHC, NCJWSTL and other partner organizations are offering free EC kits to anyone of any age. **Feel free to stop by the NCJWSTL office to pick up your kit - for you or a loved one.**
