# Tell Your Legislators to Vote No on SJR 33 and HJR 54



Anti-abortion politicians in Jeff City are retaliating against their own constituents for voting YES on Amendment 3. Now, **SJR 33**, an abortion BAN and partner bill to **HJR 54**, has just been voted out of committee and sent to the full Senate. **We need all hands on deck to keep this anti-abortion, antidemocracy resolution from moving any further!** 

These resolutions include so-called "rape and incest exemptions" to abortion bans, but only IF sexual violence survivors report to the police and seek abortion care before 12 weeks. These so-called exemptions are disingenuous and hollow, and only exist to trick voters into supporting abortion bans. Missourians won't fall for it. And we won't let these politicians trample on our newly established rights to abortion care and reproductive freedom.

# Tell Congress: Support the Global HER Act and Repeal the Global Gag Rule

The Global Gag Rule, first implemented in 1984 and reinstated by President Trump in January, bans international organizations that receive US aid from using any of their funds — whether or not from the US — to provide or even discuss abortion care. This dangerous policy impacts access to contraception, HIV prevention, nutrition assistance, malaria treatment, and more.

As a result of the Global Gag Rule, clinics close, unsafe abortions increase, health care providers are silenced, and women, children, and families are harmed. Abortion bans — at home and those we export abroad — are against our religion. We must take action to protect reproductive health care at home and around the world. The Global Health, Rights, and Empowerment (HER) Act is important legislation that would permanently repeal the Global Gag Rule, ensuring that global family planning aid recipients are free to provide high-quality, comprehensive, and accessible care.

### Urge the Missouri Legislature to Pass the Bipartisan Women's Health Bill Now!



Great news! HB 398 was voted unanimously out of committee last week. NCJWSTL also testified in support of SB 178 in the Senate last week. Let's keep the pressure on MOLEG to get it past the finish line this session!

While we know there will be no shortage of

attacks on women's health this session, the Missouri legislature also has an opportunity to pass a positive healthcare bill quickly - the Bipartisan Women's Health Bill (<u>SB</u> <u>178</u> and <u>HB 398</u>).

Last year, a critical women's health bill was just one vote from final passage, but despite wide bipartisan support - including from House leadership - the bill failed to pass due to dysfunction in the Senate. Both sides of the aisle strongly support this legislation that would treat and prevent disease, including congenital syphilis; increase access to contraception; and improve Missourians' health and wellbeing.

Laws and policies enacted recently have led to book bans and harmful regulations on our libraries. **We expect more censorship efforts in Missouri in 2025.**

# **Get FREE Emergency Contraception at NCJWSTL!**



NCJWSTL is thrilled to announce that we have partnered with the <u>Missouri Family Health Council</u> (MFHC) to distribute **FREE emergency contraception kits**! This effort is vitally important in the wake of last year's Supreme Court decision overturning Roe vs. Wade, especially in states like Missouri where abortion is illegal. Everyone should have the right to determine when and if they wish to start a family, and emergency contraception is vital in preventing unwanted pregnancies.

Also known as the morning-after pill, or by the brand

name Plan B, the emergency contraception pill is an over-the-counter form of birth control that can be taken up to five days after unprotected sex to avoid pregnancy. The goal of this effort is to reduce geographic and financial barriers Missourians face in accessing emergency contraception pills.

While supplies last, MFHC, NCJWSTL, and other partner organizations are offering free EC kits to anyone of any age. Feel free to stop by the NCJWSTL office to pick up your kit - for you or a loved one.

President Donald Trump recently signed an executive order making English the country's "official language." The move is a bureaucratic. Practically, it revokes an executive order signed by former President Bill Clinton in August 2000 that required federal agencies to provide services to people with limited English proficiency. Trump's order doesn't actually require agencies to stop providing translated documents and interpretation

services; instead, the decision will now be up to agency heads.
